Registration Fee

Orders

All orders must be in on Monday to Thursday before 17:00 so that Plaas Doepa warehouse can pack your order for courier. We will courier your package on Tuesday and Friday. We make use of The Courier Guy, Aramex and Postnet to Postnet and the cost is R100.00 a bag, if products fit in a bag it will only be R100.00. If it is more than a bag we will put your order in a box and then calculate the cost of your box by weight. The agent is responsible for his/her own courier cost.

Please Note: Client pays for their own courier.

How To Place A Order

- The agents send orders via whatsapp or place order on our website using your agent registration code.
- Promote Plaas Doepa products in their own natural form.
- Sell Plaas Doepa products at the advertised retail prices.(NO PRICE FIXING ALLOWED).
- No extra charges to customers will be made to provide for my own expenses or to profit or gain any extra income.
- Normal orders (flyers) will bear a cost of R100.00 for couriers.
