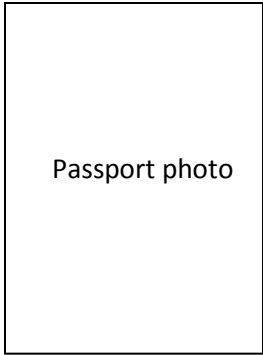

TERMS AND CONDITIONS

Thank you parent for entrusting us to register your child into our school. The following are the terms and conditions of all learners accepted into the school :

1. ALL LEARNERS TEACHERS AND SCHOOL STUFF MUST COMMUNICATE IN ENGLISH ONLY ON SCHOOL PREMISES OR DOING SCHOOL ACTIVITIES.
2. All payments for tuition must be done at the bank for 12 academic months of the year into the school account
3. No learner will be admitted into class for lessons if he /she is not wearing proper school uniform with logo.
4. All learners must be at school by 7.45am and lessons start at 8am to 2.30pm
5. The school has no responsibility of lost children who gets lost under the care of a transporter not designated by the school. The parent has the responsibility to entrust their child to a safe transport.
6. The school has it transport system that learners can use. Parents have access to the phone number of the transporter should a child gets delayed to arrive home.
7. No parent is allowed to cause harm, verbally or physically abuse the school stuff to settle a misunderstanding. Such an action will automatically result in suspension or immediate expulsion of the child from the school .
8. A child owing in fees will not be admitted to class, sit for an exam or get any school report or transfer letter until all outstanding fees are paid up in full.
9. The school may employ the power of attorneys to collect outstanding fees should it be deemed the parent's intention is to merely sabotage the education of the child or the progress of the school.
10. School reports will be sent out through whatsapp email and should there be need for print out the school must be notified in time.
11. All learners are mandated to learn extra curriculum activities according to their abilities.
12. Learners are mandated to go for an educational school trip once or twice every year.
13. All enquiries of school matters must be handled through the school office not always over the phone.
14. The parent is directly responsible to malicious damage to school property by their child.
15. The school head reserves the right to expel, suspend, discipline or punish a learner and the parent is mandated to oblige to whatever decision the made on the disciplinary action taken.
16. A learner who becomes absent must return to school with a sick-note or the parent must communicate with the school immediately the day the child misses school.
17. If a child misses school unannounced for 7 consecutive days he / she will be automatically de-registered .
18. All returning learners for next year will be obliged to pay a returning fee independent for the tuition fees.
19. Children with medical problems must let their teachers know of the medication the child may bring to school
20. All food consumed by the child must be bought from the school or brought from home. No child will be allowed to buy food from vendors outside school premises or streets to reduce the risk of food poisoning.
21. Learners are not allowed to bring to school: harmful toys, cellphones, drugs, jewellery or weapons.
22. Parents should be ready to attend to the school should there be a matter arising pertaining the child.
23. Slow learning children will be required to attend remedial lessons even on Saturdays.
